Advancing Senior Care

Over the past year, we have pursued growth and innovation while also staying firmly focused on the issues that matter most to you in delivering high-quality care to seniors.

A key example is our great progress with sector partners and government on Nursing Homes Without Walls, a game-changing model that brings LTC home resources directly to seniors in their homes – and we were proud to be chosen as the jurisdictional lead for Ontario's NFP LTC homes.

The government's Community Access to LTC pilot that supports those on LTC wait lists is also a sector success – and the kind of approach we've been advocating for to advance innovative, senior-focused care.

In our role as the first provincial hub for CanSPARK, we're excited to support pan-Canadian LTC research and contribute to nationwide innovation. These are examples of the ways we are working to encourage change and advancements in the system that will make it better for seniors.

We also had some big wins this year – government recognition and funding for emotion-focused models of care, a new capital funding program that is more supportive of NFP and municipal homes, consolidated nurse practitioner funding, and over \$600M in new funding for the sector – all significant achievements, especially in a time of economic restraint and uncertainty.

While celebrating these successes, we continued to tackle critical issues and advance key priorities and supports for members: Bill 14

provisions that will pose serious challenges to the operation and governance of homes if enacted, vulnerable sector check delays, increase in residents experiencing mental health and addictions issues, reinstating cultural LTC admissions, improving proposed life lease legislation, and addressing challenges related to HSCPOA, interRAI implementation, resident support aide changes, and more!

With the help of members, our efforts on Bill 14 seem to be paying off, and – we are hearing it may not be moving forward this fall.

I am so thrilled that our work is resonating with others – our membership has grown by 33% since 2018!



It's been a busy and rewarding year, and we hope our efforts have made a difference for you and your organization. We look forward to continuing to support your work, champion your priorities, and drive positive change in 2026.

Board members and staff brought your voice to Queen's Park on November 24, meeting with ministers, political staff, officials and opposition parties on our top priorities: LTC funding, seniors' supportive housing, and addressing increased referrals of individuals with mental health and addictions to LTC. This kind of direct, in-person advocacy that we do each year is vital to helping government understand the challenges our sector faces so it can take meaningful action.





Increased Funding: \$604M in 2025

We're delivering results that matter – turning advocacy into real dollars for seniors' care.

The 2025-26 provincial budget and inyear announcements brought major new investments across LTC, community services, home care, and housing — proof that our collective voice is driving change where it counts most.


What's Next

We have finalized our 2026-27 pre-budget submission focused on enhanced supports for LTC residents with rising acuity and expanding assisted living supports and home and community care for older adults.

Capital Investments Support NFP and Municipal LTC

We had a lot to celebrate with the government's new capital funding program. It delivered key advocacy wins and clearly showed that our message that NFP and municipal homes need specialized support was heard!

- > Eligibility is no longer time limited
- > NFP and municipal operators will receive 35% of their 85% eligible funding during construction and the remaining 65% over 25 years.
- > Planning grant doubled to \$500K for NFP and municipal LTC homes.
- > Eligible costs now include non-builtin furniture, fixtures and equipment, borrowing and financing costs, professional/ consultant fees, and land purchase.
- > Indigenous and hospital LTC operators will receive all eligible construction funding upfront.



















RESULTS

Moving Emotion-Focused Care Forward

Thanks to years of steady advocacy, emotion-focused care is gaining the attention it deserves.

The Ministry's September launch of the Improving Dementia Care Program (IDCP) marks a major step forward in recognizing and supporting these models. An investment of \$9 million over three years will support staff training and new programs for residents in up to 15 homes.

We continue to spread awareness of innovative initiatives and models of care. This spring, we hosted a three-part webinar series highlighting three emotion-focused care models.









Research and Innovation

Nursing Homes Without Walls

Over the past couple of years, we have led efforts to bring New Brunswick's successful Nursing Homes Without Walls (NHWW) program to Ontario. This innovative model supports aging in place by enabling LTC homes to provide seniors living in the community with essential services and supports where gaps exist.

Working with Health Care Excellence Canada (HEC) and The Waltons Trust, we are helping design a pilot program for Ontario and are pleased to have been selected as a jurisdictional lead for NHWW in Ontario for NFP LTC homes.

CanSPARK and OnSPARK

Canada Supporting Partnerships to Advance caRe and Knowledge in Long-Term Care (CanSPARK LTC) is an exciting and collaborative initiative with the goal of ensuring that all LTC home decisions, and care provided, are grounded in evidence and focused on the individuals who live and work in LTC Canada. We have been involved since the early stages and are proud to have been approved as the Ontario Hub!

We are also actively involved with OnSPARK (Ontario Supporting Partnerships to Advance Care and Knowledge), Canada's first and largest real-time LTC data-sharing network.

MORE RESULTS

Four Hour Target Achieved

Thanks to increased government funding and the incredible efforts of LTC homes, the sector reached a longstanding target: a provincial average of four hours of direct care!

Nurse Practitioners

Advocacy win with recently announced consolidation of NP funding.

LTC Pharmacy Freeze

We secured a freeze on pharmacy funding for 2025/26 after the government had planned cuts, and we continue to advocate for a much-needed increase.

Ward Room Funding

Successfully advocated for 100% of Level of Care funding, including OA envelope for each unoccupied third and above bed in a ward room for LTC homes with 64 or fewer beds.

Community Access to LTC

Three member organizations – Peel Manor, Wellbrook Place and St. Joseph's Villa Dundas - were announced as pilot sites for this new program, allowing seniors to access services on-site from participating homes while remaining in the community.

Staffing Agencies

Our advocacy paid off with Bill 11 bringing greater transparency for staffing agencies by requiring them to report data on their services and fees to the government.

IPAC

Our efforts helped secure regulatory amendments giving LTC homes greater flexibility to meet IPAC lead certification requirements.

Development Charges

Legislation passed in June eliminated municipal development charges for NFP LTC homes.



Action on Other Issues

Bill 14

- > Members have raised serious concerns about the heavy compliance requirements in Bill 14, Support for Seniors and Caregivers Act, 2025 - and advocating for amendments has been a top priority for the Association.
- > We have briefed officials numerous times, prepared a submission, and engaged members through our advocacy toolkit.
- > Our efforts seem to be paying off: we are hearing the Bill won't be tabled this fall.

HSCPOA

- > Registration requirements for legacy PSWs under the Health and Supportive Care Providers Oversight Authority (HSCPOA) are a significant concern and will add further strain to the sector's HHR crisis.
- > We are supporting members through education and resources - and we are getting traction in our discussions with the ministries of Long-Term Care and Health.

Wage Harmonization

> Partnering with nine other associations on #ForUsForYou campaign to urge government to close the wage gap between community health care workers and health workers in other sectors.

Cultural Homes

- > We are actively involved in the provincial pilot enabling 29 homes to prioritize crisis admissions based on religion, ethnicity or linguistic origin.
- > Progress is positive, and we continue to press for a "crisis cultural bed" category to be put in place for all cultural homes.




